Thank you for your support of the Alliant Educational Foundation. Our most recent fiscal year has been highly successful, and we're delighted to share a few of this year's highlights in this brief report.

Among many accomplishments, we're most proud of completing a bold new strategic plan, re-tooling our Innovation/Seed Grants program to better reflect the mission and values of the Foundation, continuing to support hundreds of students through scholarships across the State of California, expanding our regional children's Mental Health Consortium to better support under-resourced children and youth and their families, and launching our first-ever "AEF Fellows" program.

As you may know, the Foundation was created in 2015 when Alliant International University converted to a public-benefit corporation, and the non-profit assets, including student scholarships, faculty research grants, and land ownership, were transferred to the new Foundation.

Since then, we've continued to partner with Alliant in a wide variety of ways. Over the past year, we've donated more than \$700,000 for student scholarships across the six Alliant campuses in California. We also served as the fiscal agent for faculty grants and contracts, launched our fourth round of innovation/seed grants, and begun to expand our Mental Health Consortium to the San Francisco/Bay Area.

Along the way, we continue to work closely with our donors – all of whom have entrusted us to invest their dollars wisely to support the students and programs that make Alliant such a special institution. Generous donors have helped us grow newer funds for long-term endowments as well as special memorial funds, whenever needed.

IMPACTING STUDENT LIVES

The Alliant Educational Foundation is helping drive student success by providing targeted scholarships to well-deserving students.

Over the past year, we have partnered with Alliant International University to fund \$700,000 in scholarships and tuition support, benefiting over 800 students across the six California campuses and the schools that comprise the Alliant educational system. In total, our donations now stand at more than \$9 million over the past eight years, helping thousands of students pursue their dreams of professional practice.

Additionally, the Foundation now manages approximately \$7 million in private endowment funds targeted to a variety of scholarships and programs. In the last year alone, the Foundation invested over \$200,000 in student scholarships from these endowments.

LAUNCH OF “AEF FELLOWS” PROGRAM

2023 marks the first-ever cohort of the Alliant Ed Foundation (AEF) Fellows, a new program supporting up to 20 incoming students across the State of California in their pursuit of PhD and PsyD degrees in clinical psychology. Many of this year’s students share a commitment to social justice and community impact, high GPA’s, some level of financial need, and in some cases, are the first to attend college or graduate school in their families.

At scale, this program will support 80-100 such students with multi-year scholarships, peer connections, mentorship, and more!

SUPPORTING FACULTY + STAFF THROUGH INNOVATION/ SEED GRANTS

As part of a project to foster new innovative programs, research, publications, and enhancements within the Alliant system, the Foundation launched this program offering one-time funding for new initiatives proposed and led by current faculty and staff. This investment is for one-time “seed” funding to help launch new ventures and is available across the Alliant system to all campus locations and any school or department within the system.

In total, the Foundation has funded more than \$130,000 in grants to foster innovation and help launch a variety of new faculty-led research and student advancement ventures.

A fourth round of funding is currently pending and all grant selections will be made in the spring of 2024.



OUR NEW STRATEGIC PLAN: SETTING A COURSE FOR 2026

Starting with our Board retreat in late-June and culminating in December, a dedicated group of Board members worked with us to chart a course for the Foundation’s programs, revenue, marketing, and infrastructure through 2026. Such plans provide a robust vision of where we intend to go over the next three years while building on the many good initiatives already in place.

Broadly, the plan includes new and continuing programs to support students, faculty & staff, and the broader community, including the expansion of our regional Mental Health Consortia.

It also calls for growth in our fundraising and alumni relations roles, balanced with continuing support from donor-funded endowments and land ownership role.

RESPONDING TO COMMUNITY NEED

As part of our strategic plan, the Foundation believes it has a unique opportunity to help leverage specific strengths of students and faculty to support a broader impact in the communities where we live and work.

AEF'S REGIONAL CHILDREN'S MENTAL HEALTH CONSORTIUM

Working closely with Alliant's California School of Professional Psychology (CSPP) in San Diego, the Alliant Educational Foundation is building new bridges in support of children's mental health. At present, we're partnering with a variety of San Diego-based non-profit organizations who work with under-resourced infants, children, and young adults and their families.

The needs are great. We know from The Annie E. Casey Foundation's Kids Count Survey that children with anxiety or depression jumped 70% in California between 2016 and 2020 – and this data does not even include the adverse effects the pandemic had on the mental health of children and youth.

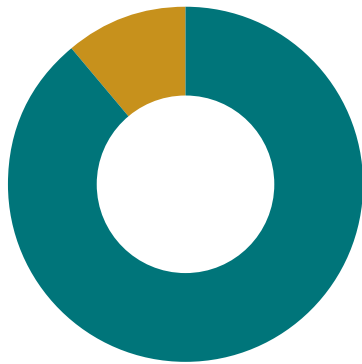
By placing CSPP clinical psychology graduate students at these agencies, we're bolstering their capacity to provide high-quality mental health support to some of the populations who most desperately need it, while also providing invaluable training opportunities for CSPP-SD students. In addition, we are helping to fill the gap in the mental health workforce in San Diego County which is expected to reach a staggering deficit of 18,000 professionals by 2027.

And we're also expanding! In 2023, AEF completed a listening tour to better understand the unmet mental health needs and under-served populations in the San Francisco/Bay Area. Input from 17 funders, direct-service providers, and CSPP faculty members helped shape the direction and focus of the Bay Area consortium—which will also focus on supporting the mental health of under-resourced children and youth, emphasizing BIPOC and non-English speaking families.

DR. JEFFREY TIRENGEL MEMORIAL STIPEND FOR COMMUNITY MENTAL HEALTH

As a founding board member of the Alliant Educational Foundation, past member of the Board of Trustees with Alliant International University, and beloved faculty member for CSPP-Los Angeles, we recognize Dr. Jeffrey Tirengel's tremendous leadership and support to both the Foundation and CSPP. The Dr. Jeffrey Tirengel Memorial Stipend for Community Mental Health was launched in 2020 to enable students participating in the Mental Health Consortium to benefit from a modest monthly stipend to support their work with under-resourced children and youth.

In our fourth year (2023), 14 students were placed at six of the youth- and family-serving agencies listed here, providing services to 165 clients and their families. Here are a few key statistics over the past year...



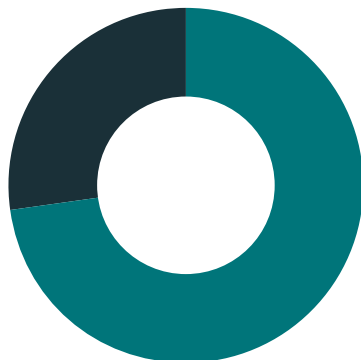

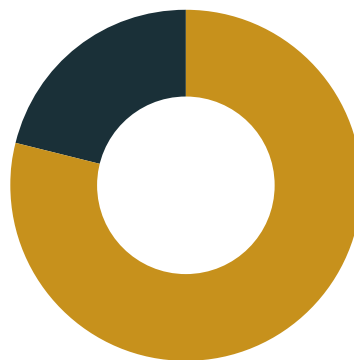

Our cost per client treated during our last program year was **\$1,102**

Of our total program expenses, **95%** covered our third-party clinical psychologist supervisors, our clinical psychologist program liaison, student stipends, and grand round training session costs.

Additionally, the program reduces the average cost of therapy sessions by **55%**
(\$89/session vs. \$200/session in CA for private therapy based on AEF research)

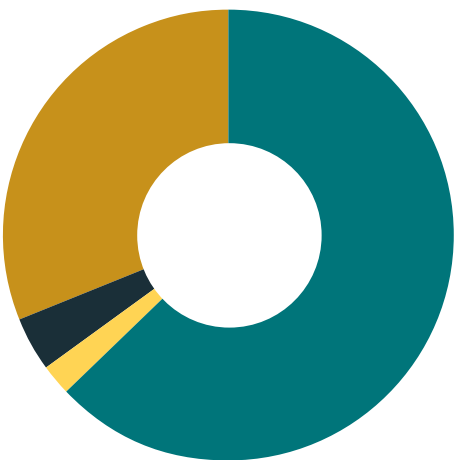

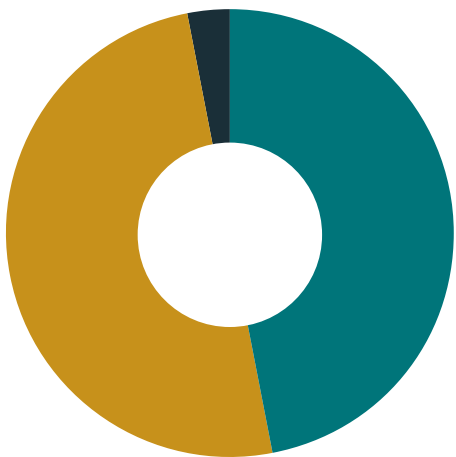
